Helping Non-Profits recover Sales Tax on their leases to help them in their fund raising campaigns, if their locations are in Shopping Centers, Shopping Malls, they may qualify.

The Non-Profits should have a 501 C3 status, and hold a current Consumer Certificate of Exemption (Form D14) to qualify for such exemptions. Both these items if not available may be applied for in certain cases.

WHAT DOES A CHURCH GAIN BY THIS EXEMPTION.

The taxes of 5.5% that is placed on most leases is exempt and can be recovered sometimes as far back retroactively as 3 years. 5.5% of monthly rent can be a beneficial amount especially if we can recover 3 years retroactively. The 7% tax that is added to the cost of sales that the Church makes annually, may be another amount that may be recoverable.

The 501 C3 status is at the Federal Level and exempts federal income tax and sales tax and must be approved by the IRS.

The Department of State handles 36 different taxes, and each one is dependent on certain conditions, that is the task we face to determine what benefits we can bring to our clients.
