The 501 C3 status is at the Federal Level and exempts federal income tax and sales tax and must be approved by the IRS.

The Department of State handles 30 different taxes, and each one is dependent on certain conditions, that is the task we face to determine what benefits we can bring to our clients.

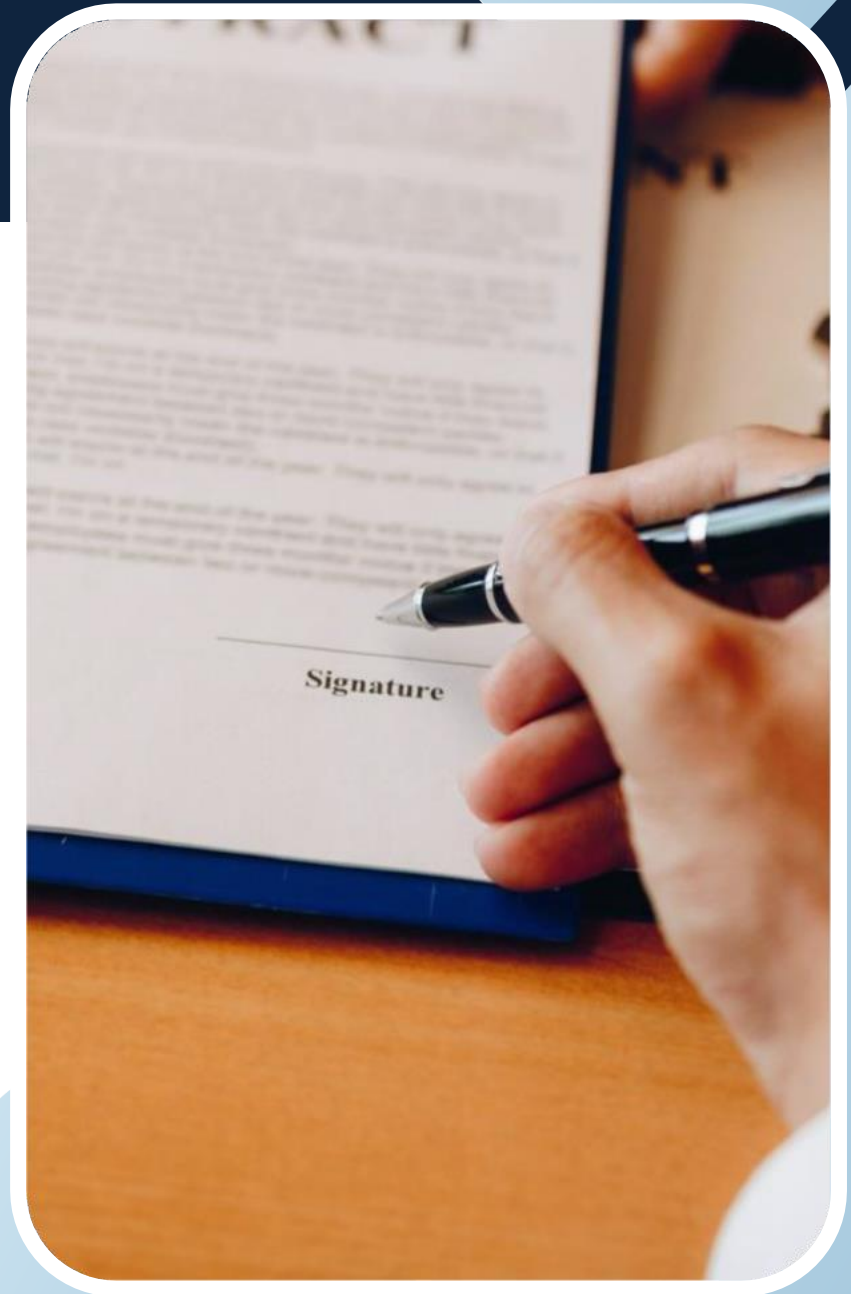

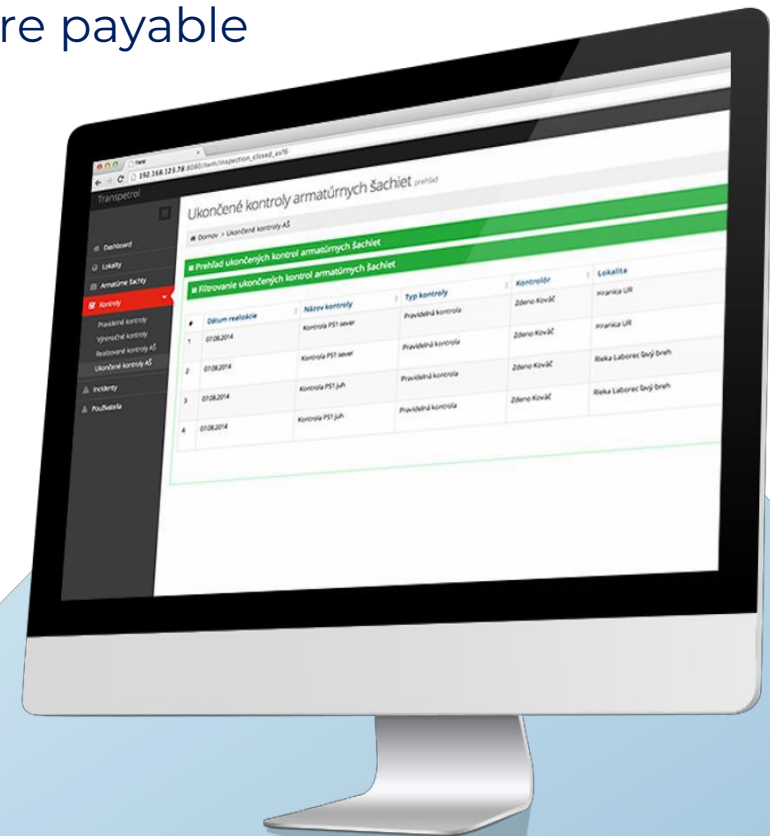
